Adjustment of Low Sulphur Surcharge (LSS)

Dear SITC customers,

According to the rules of LSS will be computed on quarterly basis average low Sulphur fuel price taken from Hong Kong and Shanghai for the preceding 3 months period, we will apply the standard of LSS for Q3/2026 as following, for mainland China to and from Japan & Korea will further notice

Mechanism of LSS Adjustment

Effective Date: 1st Jul 2026 (counting origin ETD)

Settlement: be collected at destinations

Adjustment: Quarterly

Application: All SITC services will be categorized under 4 trades (Trade A to D) as below, depending on sailing distance and size of vessels deployed

- For China – Japan, China – Korea & services between Cross-Strait region (to/from China and Taiwan), LSS adjustment mechanism to be announced
